Item No. 1: Requests for conversion of in-principle to formal approval

(i) Request of M/s Satyavedu Reserve Infracity Private Limited

In principle approval was granted for setting up of multi-product SEZ at Nellore District, Andhra Pradesh on an area of 1000 hectares, in the meeting of the Board of Approval held on 8th August 2006. The approval letter was issued on 22nd August 2006.

The developer has submitted an application seeking formal approval to the project over an area of 1023 hectares. The developer has stated that the land has been acquired and is in their possession. State Government has also recommended the proposal for formal approval.

(ii) Request of M/s Reliance Haryana SEZ

In-principle approval was granted for setting up of multi-product SEZ at Gurgaon, Haryana in the BoA meeting held on 17.3.2006, on an area of 10,000 hectares. The approval letter was issued on 31.3.2006. Later on, the developer submitted a request to transfe the approval in the name of an SPV Reliance Haryana SEZ Limited.

M/s Reliance Haryana SEZ Limited has now submitted a proposal seeking formal approval for multi-services SEZ in the land already in possession of area upto the extent of 485.6 hectares. The developer has submitted that the land in their possession is contiguous. However, a portion of the Pataudi Road passes through the present site at its edge land measuring 45.56 hectares is on one side of this road and the balance land is on the other side. Most of the land on which the road exists is in the ownership of Reliance Haryana SEZ Limited. The developer has assured that they shall maintain contiguity by constructing underpass/ over bridge. The request of the developer is submitted for consideration.

(iiii) Request of M/s Hindalco Industries Limited

In-principle approval was granted for setting up of sector specific SEZ for aluminium and aluminium products (with captive power plant) at Sambalpur, Orissa in the BoA meeting held on 8.8.2006, on an area of 855 hectares. The approval letter was issued on 22.8.2006. پور

M/s Hindalco Industries Limited has now submitted a proposal seeking formal approval. They have informed that they have identified the land and is in the process of acquiring the land on lease from IDCO. The applicant has entered into an MOU with the State Government, under which the State Government has agreed to facilitate in providing the necessary land for this purpose.

The developer has further informed that the processing area which is 735 hectares is a contiguous one and there is no thoroughfare. However, the township, which is 120 hectares of land and which as a non-processing area does not require any fencing and authorization and is separated by a road and railway line from the processing area. Further, there is also an ash dump with green belt cover, space for afforestation and expansion, which is connected by the processing area by mean of a pipeline for carrying the ash.

DLF Asset Private Limited (DAPL) has been granted approval to codevelop IT/ITES SEZ in DLF City, Gurgaon. DAPL is proposing to undertake the co-development activities through FDI of USD 349 Million (Approx Rs 1500 crores) in the first tranche. This is submitted for taking note of.

Item No. 3: Requests for authorized operations

(i) Request of M/s Satyam Computers (Co-developer) for authorized operations in the IT/ITES SEZ at Chennai, Tamil Nadu proposed to be developed by ELCOT

The above SEZ was notified on 11th April 2007 on an area of 152.66.5 hectares. M/s Satyam Computers Services Limited was approved as one of the co-developer in developing an area of 20.23 hectares in the meeting of the BoA.

The co-developer has now submitted a list of the authorized operations to be carried out in the said SEZ which is at **Annexure 1** for the consideration of the Board.

(ii) Request of M/s Virtusa (India) Private Limited for authorized operations in the IT/ITES SEZ at Nanakramguda, Ranga Reddy District, Andhra Pradesh to be developed by APIIC

The above SEZ was notified on 25th April 2007 on an area of 20.53 hectares. M/s Virtusa (India) Private Limited was approved as one of the codeveloper in developing an area of 2.56 hectares in the meeting of the BoA held on 26th April 2007. The co-developer has now submitted a list of the authorized operations to be carried out in the said SEZ which is at **Annexure 2** for the consideration of the Board.

Item No. 4: Request of M/s. Ansal IT City and Parks Limited for enhancement of quantum of authorized operations in the non-processing area

IT/ITES SEZ at Tech Zone, Greater Noida, U.P. by was notified Anal IT City and Parks Limited was notified on 29.8.2006 on an area of 30.41 hectares. The request of the developer for authorized operations was approved in the meetinb of the Board of Approval held on 2.2.2007. While conveying the approval, the quantum for various authorized operations like shopping arcade/retails space, housing/service apartments were also conveyed.

The developer has now informed that they have allowed certain operations like residential and commercial to be developed under the project zoning guidelines. Moreover the area of the SEZ (i.e. 30.41 hectares) is for more than the minimum area stipulation of the IT/ITES SEZ i.e. prescribed in the SEZ Rules. The built up area proposed by developer as per the Greater Noida by laws and lease deed executed is as follows:

developer has further stated that FAR in their case is higher i.e. 1.875 which permits them to develop a greater build up area.
