2.3(24) Proposal for conversion of existing DTA unit into EOU unit – M/s Intas Pharmaceuticals Limited under KASEZ.

M/s Intas Pharmaceuticals Limited, engaged in pharmaceuticals business, has applied for conversion of their existing DTA unit along with additional location of the existing DTA unit into 100% EOU for manufacture of Formulations - Tablets, Formulations - Capsules, formulations - Injectables (Vials / Ampoules), Formulations - External Preparation (Ointment / Cream / Tube / Topical solution / Drops / Spray), Bulk Drugs / Intermediates / Chemicals and services of Research and Development of Pharmaceutical formulation development, API development.

Export Projection of the unit for the next 5 years (in crores)

The proposal of the unit was considered by BoA in its 1st meeting held on 06.02.2024. The board after deliberations, deferred the proposal in view of the pending EODC certificates for EPCG Scheme with Regional Authorities (RA) of DGFT.

In this regard, DC-KASEZ has informed that the unit was issued 27 EPCG Authorisations, EODC certificates of which have been received by them on 16.02.2024. Further, the unit is under export obligation of Rs. 408.55 crore against 178 Advance Authorization cases.

Relevant provision: Para 6.18 (c) of FTP 2023 stipulates that "Applications for conversion into an EOU unit from existing DTA units, having an investment of Rs. 50 crores and above in plant and machinery or exporting Rs. 50 crores and above annually, shall be placed before BOA for a decision."

Further, as per para 6.38 of HBP 2023, in case there is an outstanding export commitment under Advance Authorisation Scheme, it will follow the procedure laid down in Appendix 6M of Appendices & ANFs.

DC's Recommendation: DC-KASEZ has recommended the proposal of the unit.
