Item No. 3.1(25) Confirmation of Minutes of the 2nd BOA meeting (2025 Series) held on 24.01.2025.

Item No. 3.2(25): Conversion of existing DTA unit into EOU [03 proposals – 3.2.1-3.2.3(25)]

3.2.1(25) Proposal for conversion of existing DTA into EOU unit - M/s SSK Exports Limited under the jurisdiction of FSEZ.

The Board, after deliberations deferred the decision for the proposal of the unit for conversion of existing DTA into EOU unit.

The Board directed DC, FSEZ to seek complete detailed item wise import data of the unit for last 5 years including the countries from which imports and exports have been made; the names of the countries to which the unit will export; and from whom does it plan to import after conversion as an EOU. Board also directed EOU Division to seek inputs/comments of the Tea Board (through plantation Division) on the proposal.
