**Item No. 5.1(25) Confirmation of Minutes of the 4<sup>th</sup> BOA meeting (2025 Series) held on 06.06.2025.**


The BOA ratified the Minutes of its 4<sup>th</sup> Meeting (2025 Series) for EOU Scheme held on 06.06.2025.

**Item No. 5.2.1(25) Proposal for Extension of Letter of Permission beyond six months after expiry of validity – M/s Adgums Pvt. Ltd., Ahmedabad under the jurisdiction of KASEZ to continue as EoU.**

The Board, after deliberations, approved the proposal for extension of validity of Letter of Permission (LoP) dated 31.03.2003, beyond 14.12.2023, for a period of 5 years from 15.12.2023 to 14.12.2028, subject to the provisions laid down in FTP 2023 read with HBP 2023, and in accordance with the provisions of Para 6.01(h) of HBP 2023 after considering the belated option given by the Unit to continue as EoU beyond six months from expiry of validity of the last LoP.


