NOTIFICATION

S. O. 1841(E).- Whereas M/s. Madhya Pradesh Audyogik Kendra Vikas (Jabalpur) Limited has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the said Act) to set up a sector specific Special Economic Zone for mineral and mineral based products sector at village Hargarh, Tehsil Sehora, District- Jabalpur, in the State of Madhya Pradesh;

And whereas, the Central Government is satisfied that requirements under sub-section (8) of section 3 of the said Act, and other related requirements are fulfilled and it has granted letter of approval under sub-section (10) of section 3 of the said Act for development and operation of the sector specific Special Economic Zone for mineral and mineral based products sector at the said Hargarh village in the State of Madhya Pradesh on 17th March, 2008;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 4 of the Special Economic Zones Act, 2005 and in pursuance of rule 8 of the Special Economic Zones Rules, 2006, the Central Government hereby notifies the following area at village Hargarh, Tehsil Sehora, District- Jabalpur, in the State of Madhya Pradesh, comprising of the Survey numbers and the area given in the Table below, as a Special Economic Zone, namely: -
