## **NOTIFICATION**

**S.O. 1992(E).-** Whereas M/s State Industries Promotion Corporation of Tamil Nadu, has proposed under section 3 of the Special Economic Zones Act, 2005 (28 of 2005), (hereinafter referred to as the said Act), to set up a sector specific Special Economic Zone for leather sector at State Industries Promotion Corporation of Tamil Nadu Industrial Complex, Ranipet Phase-III, Mukuntharayapuram village, Walajah Taluk, Vellore District, in the State of Tamil Nadu.
